

# Bachelor's degree programme in CHEMISTRY FOR INDUSTRY AND ENVIRONMENT (L-27)

## ONLINE REGISTRATION FOR SELECTION

### 1. Register at [www.studenti.unipi.it](http://www.studenti.unipi.it) (Alice portal)

To register, you must enter personal data when requested throughout the procedure. Follow the instructions and at the end of the procedure you will receive a user name and you must choose a password. As well as entering personal data, in order to be registered for the admission exam you must go into your personal area and click on 'Enrolment for Admission Exams'.

#### Start registration

If you are already a student of the University of Pisa you must access the Alice portal using the user name and password you normally use for online services at the University of Pisa, and click on 'Enrolment for Admission Exams'.

### 2. Select the admission exam

You can enrol immediately after having completed the registration process: in which case you only need to follow the instructions provided at the final phase of registration. If you would like to enrol at another time, you must enter the Alice Portal using the username and password provided at the end of registration and choose the menu item "Enrolment for Admission Exams".

### 3. enrolment procedure

*The enrolment procedure will be released shortly.*

Online registration is allowed for the first 60 students. All other students will be considered on a waiting list and are invited to check their position on a daily basis and before any re-opening of registrations (see table). You will not be personally notified of any changes, so you are required to monitor your position in the aforementioned manner.

If you are registered online by the 3<sup>rd</sup> August 2017, you must complete the enrolment procedure between the 27<sup>th</sup> July 2017 and the 3<sup>rd</sup> August 2017, otherwise you will not be able to enrol.

In the case of vacancies, each admitted candidate is required to verify their own position by connecting to the portal [www.studenti.unipi.it](http://www.studenti.unipi.it) and they will be able to proceed to enrolment from the day after they have registered online, and within the deadline indicated in the table. The enrolment procedure will be reopened according to the following dates:

5th October 2017	25th October 2017

If by the 26th October 2017 there are still some vacancies, these will be made public on the website <http://matricolandosi.unipi.it/chimica/> for an additional enrolment period.

### **3. evaluation of initial preparation**

For the purpose of evaluating the initial preparation and therefore of the assignment of any Additional Academic Obligations (Obblighi Formativi Aggiuntivi-OFA), all enrolled students must take the TOLC-I test. The compulsory and non-selective test can be taken either before enrolment or after.
